Established in 2018


Increase equal access to housing opportunities, promote success in permanent housing for the hardest to house individuals & families and provide HMIS support for Missouri Continua

# MoHIP Grant Types







## MoHIP Components - CES

#### Coordinated Entry System (CES)

- o Purpose
  - o To assist in the operation of a Continuum of Care's CES
- Eligible Recipients
  - o CoC recognized CES "access points"
- o Eligible uses
  - Staff salary/benefits
  - o Equipment (hardware & software)
  - o Supplies
  - o Mileage for staff travel associated with CES activities
  - Software Licenses





# MoHIP Components - HMIS

#### **HMIS**

- Eligible Recipients
  - o CoC designated HMIS Lead Agencies
- o Purpose
- o Eligible Uses
  - Staff salary/benefits
  - HMIS Software Costs
  - Hosting & Technical Services

# **Basic Agency Information**

- Agency Information
  - o Provide the full legal name for the agency
  - o Provide the complete address
- Agency Contacts
  - List contact information for a grant contact
  - o List the agency's Executive Director information





# **Proposal Information**

#### Applicant Type

- o If you are the CoC designated HMIS lead, you will select HMIS Lead Agency
- o If you are a Coordinated Entry access point, you will select Coordinated Entry Point
- o If you are applying for both Coordinated Entry and HMIS funding, you will select Coordinated Entry Point and HMIS Lead

#### Requests by Grant Type

- o Enter total amounts being requested by grant type
- o If not requesting funds in a grant type, please enter '0'





# **Proposal Information**

- Coordinated Entry
  - Explain how your organization participates with your CoC's Coordinated Entry System
- Need and Data Explanation
  - o Demonstrate the need for MoHIP funding using data
  - o Explain the need for MoHIP funding with quantifiable data
    - This can be done by presenting local, state, national or internal data regarding homeless populations and/or the effectiveness of the use of MoHIP funding in the context of ending homelessness
- o Grant Use
  - Explain specifically how you anticipate using the funding of this grant, based on the allowable uses outlined in the application guidance and desk guide?





### Attachments

#### Board of Directors

o A complete list of organization's current board or governing members

#### Sources and Uses

o MoHIP budget- revenue uses and sources of that funding

#### Letters of Support

o Two letters that demonstrate the support of the MoHIP program





## **Attachments Continued**

- Certificate of Good Standing
  - o Current within 60 days of application due date
- o501 (c)(3) Verification
- oAudit/Financials
  - o Only include the independent auditor's report, not the entire audit





# **Grant Components**

#### Budget and Detail

o Should match the amounts reflected in the Proposal Information section

#### Narrative

o Fully address each item specified in the question in a clear and concise manor







# Applicant Requirements



## Continuum of Care Participation

- Applicants assessed for involvement in CoC
  - Support from CoC; considered a member in good standing
  - Representation at full meetings
  - o Point-In-Time Count
  - Participation within CES
- Grantees required to attend at least 75% of CoC meetings





## Coordinated Entry System Participation

- Consistent, uniform assessment and referral process for diversion, prevention, shelter, RRH, PSH, and/or other housing-related services
  - Processes/documents are same for all homeless service providers in the community
  - Reduces duplication of services
  - o Clients referred to programs for which they are eligible
  - o Maximizes efficiency and effectiveness







# **Grant Administration**



#### **Grant Administration**

- Requirements of MoHIP Grantees
  - Quarterly Back-Up Submission
  - o 25 percent Back-Up deadline
  - 75 percent Back-Up deadline
  - Recordkeeping Requirements
    - o Financial Documentation
  - Monitoring
  - o Close Out





#### **Grant Administration**

- Financial Processes
  - o Funding Period: January 1, 2025 December 31, 2025
  - $\circ\,25\%$  of the total grant award amount will be advanced at the start of the grant year
  - Any advance of funds must be backed up before additional funds will be disbursed to a grantee
