Program Overview

Missouri Housing Innovation Program

- Established in 2018
- Increase equal access to housing opportunities, promote success in permanent housing for the hardest to house individuals & families and provide HMIS support for Missouri Continua
- Consolidation of three previous MHDC grant programs

MoHIP Components - CES

Coordinated Entry System (CES)

- Purpose
 - To assist in the operation of a Continuum of Care's CES
- Eligible Recipients
 - CoC recognized CES "access points"
- Eligible uses
 - Staff salary/benefits
 - Equipment (hardware & software)
 - Supplies
 - Mileage for staff travel associated with CES activities
 - Software Licenses

MoHIP Components - HMIS

HMIS

- Eligible Recipients
 - CoC designated HMIS Lead Agencies
- Purpose
 - Funds are intended to assist CoC HMIS Lead Agencies in providing homeless assistance provider agencies in their use of HMIS in order to record and track accurate data, build reports & forms, and provide data to MHDC or appointed agency
- Eligible Uses
 - Staff salary/benefits
 - HMIS Software Costs
 - Hosting & Technical Services

Basic Agency Information

- Agency Information
 - Provide the full legal name for the agency
 - Provide the complete address
- Agency Contacts
 - List contact information for a grant contact
 - List the agency's Executive Director information
- Agency website and Fiscal Year
 - List your agency website
 - Put what is the fiscal year for your agency

Proposal Information

- Continuum of Care

- Select the CoC you are applying for MoHIP funds for
- If your organization operates in multiple CoCs, you must submit separate applications for each CoC

- Applicant Type

- If you are the CoC designated HMIS lead, you will select HMIS Lead Agency
- If you are a Coordinated Entry access point, you will select Coordinated Entry Point
- If you are applying for both Coordinated Entry and HMIS funding, you will select Coordinated Entry Point and HMIS Lead

- Requests by Grant Type

- Enter total amounts being requested by grant type
- If not requesting funds in a grant type, please enter '0'



Proposal Information

- Coordinated Entry
 - Explain how your organization participates with your CoC's Coordinated Entry System
- Need and Data Explanation
 - Demonstrate the need for MoHIP funding using quantifiable data
 - Explain the need for MoHIP funding with quantifiable data
 - This can be done by presenting local, state, national or internal data regarding homeless populations and/or the effectiveness of the use of MoHIP funding in the context of ending homelessness
- Grant Use
 - Explain specifically how you anticipate using the funding of this grant, based on the allowable uses outlined in the application guidance and desk guide



Attachments

- Board of Directors

- A complete list of organization's current board or governing members

- Sources and Uses

- MoHIP budget- revenue uses and sources of that funding

Attachments Continued

- Certificate of Good Standing
 - Current within 60 days of application due date
- 501 (c)(3) Verification
- Audit/Financials
 - Only include the independent auditor's report, not the entire audit

Grant Components

- Budget and Detail

- Should match the amounts reflected in the Proposal Information section

- Narrative

- Fully address each item specified in the question in a clear and concise manor

Continuum of Care Participation

- Applicants assessed for involvement in CoC
 - Support from CoC; considered a member in good standing
 - Representation at full meetings
 - Point-In-Time Count
 - Participation within CES
- Grantees required to attend at least 75% of CoC meetings



Coordinated Entry System Participation

- Consistent, uniform assessment and referral process for diversion, prevention, shelter, RRH, PSH, and/or other housing-related services
 - Processes/documents are same for all homeless service providers in the community
 - Reduces duplication of services
 - Clients referred to programs for which they are eligible
 - Maximizes efficiency and effectiveness

Grant Administration

- Requirements of MoHIP Grantees
 - Quarterly Back-Up Submission
 - 25 percent Back-Up deadline
 - 75 percent Back-Up deadline
- Recordkeeping Requirements
 - Financial Documentation
- Monitoring
- Close Out



Grant Administration

■ Financial Processes

- Funding Period: January 1, 2026 - December 31, 2026
- 25% of the total grant award amount will be advanced at the start of the grant year
- Any advance of funds must be backed up before additional funds will be disbursed to a grantee
